Department of Foreign Languages Funding of doctoral fellows on the quota scheme

(grants, travel and fieldwork expenses, overheads, equipment, thesis defence expenses and dissertation)

The following sources of funding are available under the quota scheme to doctoral fellows at the Department of Foreign Languages:

- 1) Lånekassa (the Norwegian State Educational Loan Fund) pays a monthly stipend
- 2) Lånekassa funds travel to Norway at the beginning of the grant period
- 3) Lånekassa funds one or more periods of fieldwork (travel expenses) during the grant period
- 4) Lånekassa covers the return journey from Norway on completion of the doctorate, so long as the journey is undertaken no later than three months after the doctoral thesis has been submitted.
- 5) Doctoral fellows have access to overhead funds that may be used for purposes relevant to their theses (books, equipment, seminars, travel, etc.)
- 6) All doctoral fellows will have a PC provided by the Faculty
- 7) Everyday office sundries are provided by the Department
- 8) The Department covers printing of 25 copies of the completed thesis
- 9) The Department will give up to Kr 3000 for a doctoral dinner or other celebration organised by the doctoral fellow
- 10) Applications for funding for special purposes should be planned in consultation with the supervisor and/or research consultant

<u>Travel expenses (2, 3 og 4):</u> The rates will vary, dependent upon which continent the PhD student hails from. For the academic year of 2010/2011 the rates are as follows for one-way journeys: Africa NOK 4300, Asia NOK 3600, Europe NOK 1050, North and Central America NOK 3900, Oceania NOK 5700, and South America NOK 5000.

Hence the funding for a return trip to for instance Cameroon will amount to Kr 8600, supplemented by some additional funding for domestic travel.

Lånekassa can provide funding for one annual journey to the doctoral fellow's home nation, either for the purpose of field work or a summer holiday. Fieldwork must of course be planned in consultation with the supervisor. Lånekassa does not fully cover the cost of travel between Cameroon and Bergen, and the fellow must cover the remaining costs. Fellows will normally cover board and living expenses during fieldwork out of their monthly grant from Lånekassa.

Doctoral fellows normally travel to their home country after submitting their thesis, and return to Bergen for the trial lecture and defence. The Department cannot provide additional funding for travel and living expenses in connection with the lecture and defence. These expenses must be covered by fellows, using their own funds, remaining fieldwork/overhead allowances, etc.

In some cases doctoral fellows choose to remain in Bergen during the period between submission of their thesis and the trial lecture and defence. The living costs must be covered by fellows, using their own funds, remaining fieldwork/overhead allowances, etc.

This period should not normally exceed 3 months, but may be extended if there are good academic reasons for doing so. The fellow should apply for a residence permit for the entire period up to the thesis defence before travelling home.

Overhead funds (5): The doctoral fellows will normally be granted an annual allowance of 24000 NOK, for overhead funds, over a period of three years. These funds can be allocated to a variety of academic activities relevant to work on the PhD thesis, e.g., books, seminars, conferences, computer programmes, etc. Overhead funds can also be transferred to the budget of the subsequent academic year. However, funds that are not spent by the completion of the allocated time for the stipend will be reimbursed to the department.

<u>PC provision (6):</u> The fellow may chose either a desktop PC or laptop, but the Faculty will only cover expenses for one or the other. A doctoral fellow who receives funding for a desktop PC and then wants to purchase a laptop in addition, must use his/her overhead funds to purchase the latter.

<u>Defence dinner (9):</u> The fellow may choose to have a party, reception, doctoral dinner, etc. to mark completion of the doctorate. On application, the Department will provide up to Kr 3000 for this purpose.

<u>Funding for special purposes (10):</u> Fellows can not normally count on additional funding beyond that which is covered in §1-9 above. But in special cases they may apply for, e.g., research grants from the Department. There are also certain other sources of funding at the Faculty that may be relevant.
